# STATE OF ILLINOIS BUYING PLAN

## Calendar Year 2026

On behalf of nearly 20 State Agencies, Central Management Services (CMS) launched the State of Illinois' Quarterly Buying Plan. The Plan is designed to serve as a single-destination for useful information to the State's vendor community and to make vendors aware of the upcoming purchasing needs for a range of agencies. This initiative is led by the Bureau of Strategic Sourcing (BoSS) team, who is committed to expanding the content of the document so that vendors interested in providing their goods and/or services to the State are informed, prepared, and ready to respond to the State's solicitations.

In addition to the quarterly forecast of upcoming opportunities, the most recent addition of the Plan features sections on doing business with the State, small and disadvantaged business programs, an overview of registration and pre-qualification requirements and how to access technical assistance.

## Doing Business with the State

All vendors submitting bids and offers on Illinois public contracts must:

- **Register with the the Illinois Secretary of State** as a legal entity (other than individuals acting as sole proprietors) in good standing prior to submitting a bid, offer, or proposal. This applies to both in-State and out-of-State firms.

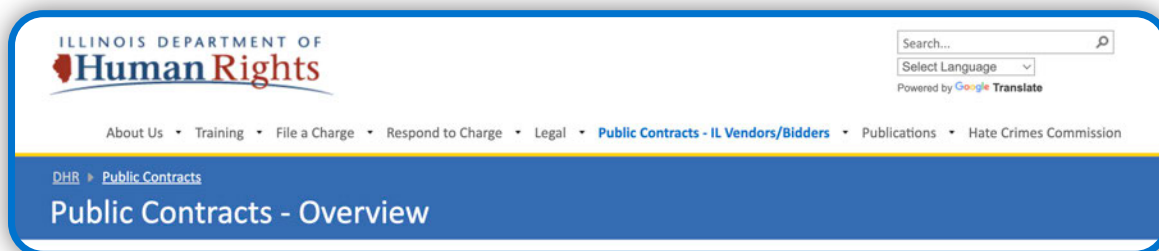
- **Register with the Illinois State Board of Elections** and obtain a certificate confirming your registration. This applies if you have aggregate bids, proposals, or contracts exceeding \$50,000 annually, including the business you do with all State of Illinois agencies and universities and the value of any current solicitations to which you are responding.

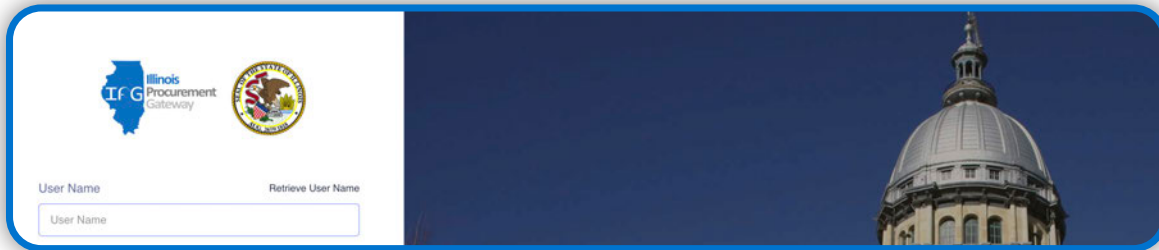
- **Hold a current Illinois Department of Human Rights (IDHR) Eligibility Number** which is obtained by filing an Employer Report Form (PC-1) with the IDHR Public Contracts Unit.

- **Register as a Vendor in the Illinois Procurement Gateway (IPG)** to submit the IPG Active Registered Vendor Disclosure form (formerly Forms B) when responding to solicitations, creates a shell vendor profile in BidBuy via an interface, and is the certification mechanism for the Small Business Set-Aside Program.

## BidBuy

The State of Illinois publishes procurement opportunities and other notices in its eProcurement system, BidBuy. **Solicitations for goods and services required by the State of Illinois are only published on BidBuy. Vendors must register in BidBuy to provide a bid or offer to solicitations.** If a vendor is registered in the Illinois Procurement Gateway (IPG), a BidBuy registration is started in BidBuy, but not completed. The Vendor must go into BidBuy to complete the registration. If a vendor did not complete an IPG registration, there is no cost to register in BidBuy but it does require specific information about your firm to be provided.

When registering in BidBuy, Vendors must identify which National Institute of Governmental Purchasing (NIGP) service or commodity codes relate to the goods or services that the business provides. The Vendor's selections should reflect what goods or services that the business provides, not what it uses in the course of business. All solicitations published on BidBuy are classified by NIGP code(s). When the NIGP Code of the solicitation matches the NIGP Codes you selected for your business, you will automatically be notified of the procurement opportunity by email.

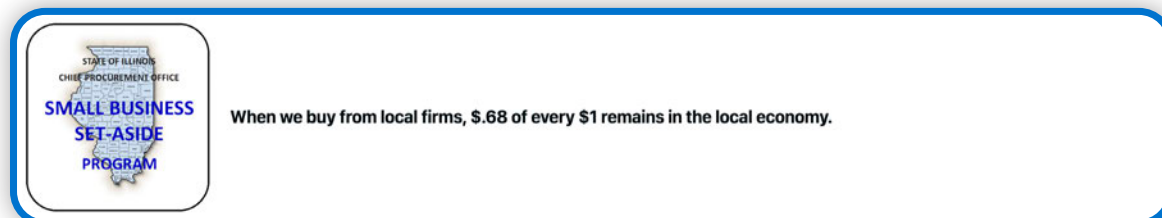

## Procurement List

The following spreadsheet is the list of upcoming procurements for the State of Illinois. The procurements will be published on the BidBuy procurement system. (Please see page 4.) The “Anticipated Publication Date” is the quarter of the calendar year in which the procurement should be published.

State law does not allow any State employee to discuss a procurement’s specific details prior to it being published to the public on BidBuy. Questions asking for procurement specific information cannot be answered.

The Buying Plan is not an exhaustive list of upcoming procurements. There may be procurements not listed in the Buying Plan that will be published on BidBuy. Please check BidBuy periodically for these procurements. Also check that you are registered for the NIGP Codes relevant to your company to receive emails of published procurements. (Please see page 4 for information on the NIGP Codes for BidBuy and procurements.)

## Buying Plan Notes

The “Opportunities” column indicates if the procurement includes a Business Enterprise Program (BEP) subcontracting opportunity or is a Small Business Set-Aside (SBSA) procurement. If the column indicates it’s To-Be-Determined (TBD), then the procurement is in its early stages, and it has not been determined if the procurement will have a BEP subcontracting opportunity or is subject to Small Business Set-Aside. Please see page 5 above for more information on the Business Enterprise Program and the Small Business Set-Aside Program.

The “Estimated Value” column includes any renewals included in the procurement.

The “Estimated Term” column is in months.

The “Anticipated Publication Date” is for the calendar year.
