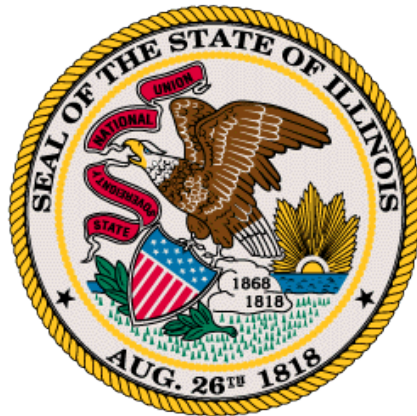

To the Honorable Members of the General Assembly:

I am pleased to submit the Recycling and Recycled Paper Procurement Update Report for Fiscal Year 2009.

In furtherance of our efforts to increase recycling activities at State government locations and specifically at sites managed by CMS pursuant to the Executive Reorganization Act (15 ILCS 15/11.), the CMS I-Cycle program, under the coordinated oversight of the Green Government Coordinating Council, shall expand its geographic and operational coverage in terms of participating facilities and the variety of recycled waste streams, thus saving energy and conserving resources.

In addition to our hands-on recycling activities, the Department of Central Management Services (CMS), through the State's procurement process negotiates master contracts for various recycled-content paper products, including paper (i.e., copy and print paper,) computer forms, envelopes, calendars and toilet tissue. The master contracts are used by State agencies, boards, commissions, and universities for their procurement needs. The CMS Bureau of Strategic Sourcing and Procurement (BoSSAP) continues to purchase other items with high recycled content, including laser printer cartridges, trash can liners, re-refined motor oil, and retread tires.


In fiscal year 2009, a new master contract was established for cradle-to-cradle recycled carpeting and carpet tiles. The carpet is at least 25% recycled content and the vendor must take it back for reuse or recycling at the end of its life.

The State and University Employees Combined Appeal (SECA) charity program chaired by CMS is a program to support charities that provide critical services to countless people less fortunate than us. In an effort to be sustainable and reduce cost, an electronic copy of the booklet and pledge form are now used instead of paper and also available at the SECA website.

CMS continues to recycle its surplus computers, cell phones and other electronic equipment to prevent leaks of mercury, lead and other toxins into the environment.

CMS is strongly committed to the ongoing "greening" of State government and its purchasing environmentally preferable procurement activities. Your continued support of these initiatives and goals is very much appreciated.

## **FY 2010 Program Goals:**

Add recycling services of locations throughout field locations

Expand plastic recycling in the Springfield Government Offices contingent on the conditions of the recycling markets and also the feasibility of additional recycling services.

I-Cycle continues to monitor the recycling market conditions and also the feasibility of expanded recycling programs throughout Illinois Government.

The Department of Central Management Services and the Illinois Green Governments Coordinating Council are seeking cooperatively ways to “green” Illinois State government.

## **I-CYCLE Program Statistics**

The Solid Waste Management Act (SWMA) directs the Department of Central Management Services (CMS) to implement recycling programs in State offices. 415 ILCS 20/3. Sites range from those as large as the James R. Thompson Center in Chicago and the Willard Ice Building in Springfield to individual agency field offices statewide.



Paper and cardboard are the primary materials recycled through the program. Site output, vendor availability or limitation, and market fluctuations all play a role in determining what materials a site recycles.

Paper and cardboard are the primary materials recycled through the program. Site output, vendor availability or limitation, and market fluctuations all play a role in determining what materials a site recycles. I-CYCLE coordinates with vendors in different regions to collect paper from State locations on a no charge/no pay basis: this means the vendor collects the material at no charge, keeping the proceeds in return. Since these collections are usually combined with the vendor's regular routes, weights for these sites are not available.

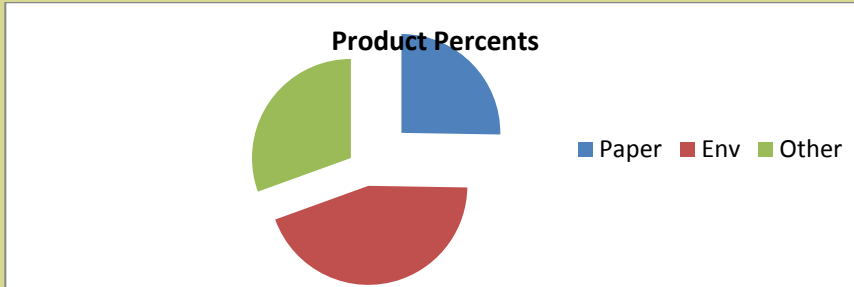

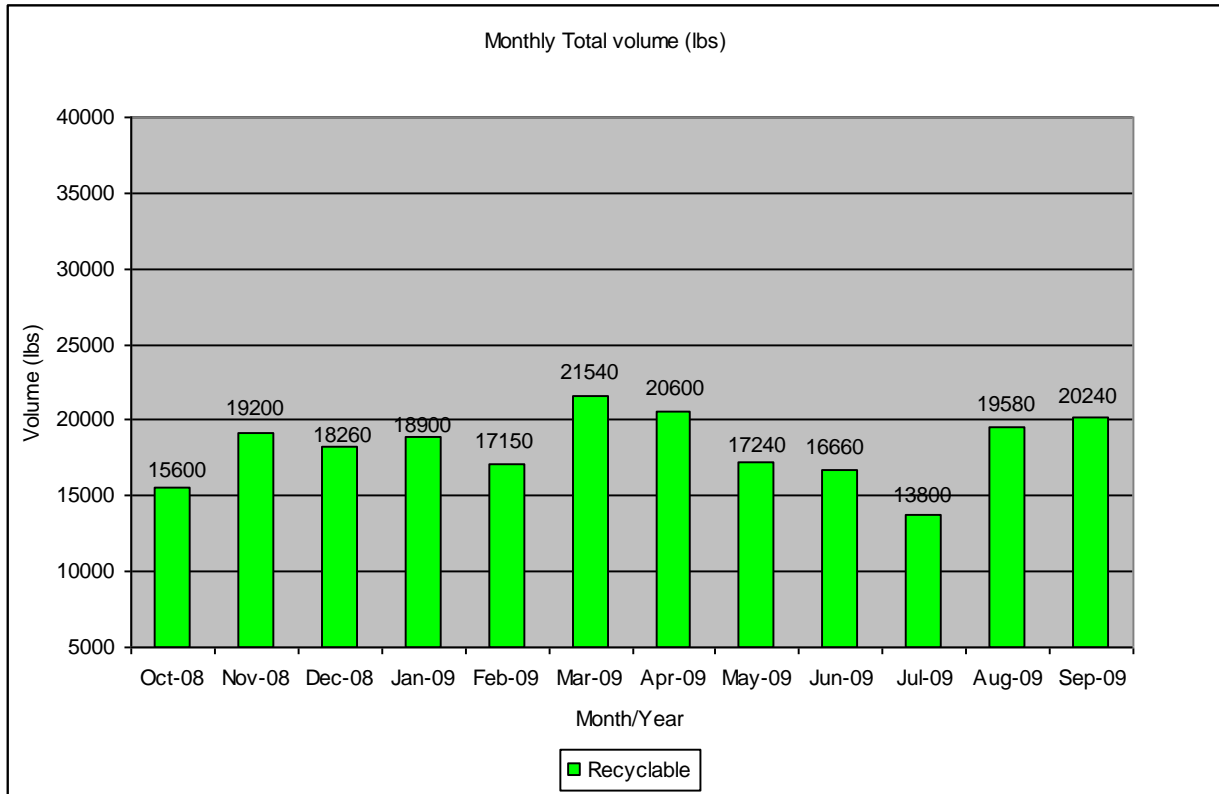
