WANT TO TURN IN LESO PROPERTY?

If your Law Enforcement Agency has property that is no longer being utilized or is no longer needed, please contact the Illinois LESO Office at 217-558-1425 to begin the LESO turn-in process. LESO turn-in requests must be done prior to March 1, 2024.

NEED LESO TRAINING?

It is vital that both those who are assigned to handle your LESO inventory and those who are assigned LESO property understand the LESO Property Requirement. To assist your LEA, we have created LESO training. Click [HERE](#) to access the training.

HAVE A NEW CHIEF OR SHERIFF?

If your Law Enforcement Agency has a new Chief Law Enforcement Officer, a new LESO packet is required to update your LEA's information. Please contact our office at 217-558-1425 to request a new LESO packet.



WHAT ACCOUNTS DOES YOUR LEA NEED TO PARTICIPATE?

AMPS: AMPS is where you create and maintain your user ID and password for RTD. If your LEA does not already have someone with an AMPS account, click this link for [Printable PDF Instructions](#). Click [HERE](#) to go to AMPS.

RTD: RTD is where you are able to search for and request property that is available through the LESO program. If your LEA does not already have someone with an RTD account, please complete the AMPS account creation first and then click [HERE](#) for instructions on how to enroll in RTD. Click [HERE](#) to go to RTD.

FEPMIS: FEPMIS is where you maintain the inventory that you have acquired through the LESO program, as well as LEA information. If your LEA does not already have someone with a FEPMIS account, click [HERE](#) for instructions and click [HERE](#) to go to FEPMIS.

NEED A HMMWV OR WANT TO TURN ONE IN?

If you currently have a HMMWV that is in running condition and no longer need it, we may be able to transfer it to another LEA.

If you are an LEA that is in need of a HMMWV, we may have an LEA in Illinois that would like to transfer one.

If you have a HMMWV that is in non running condition it will need to be turned in.

WHAT TYPE OF PROPERTY IS AVAILABLE?
