- Know the controlled property definition changes

- Be transparent with your local civilian community
- Notify your local governing body
- Have clear SoP's on equipment acquired through the program
- Know the policies, procedures, and requirements

Controlled Property*



The Addendum adds additional items to the controlled property definitions



Title and ownership of controlled property remains with the DoD, regardless of DEMIL and/or integrity Code



The LESO retains final authority to determine what items qualify as controlled property

Prohibited items issued for Limited purpose

EO 14074 lists items as prohibited from issue through LESO; however identifies specific authorized uses for these prohibited items. If requested, property must be certified annually that they are being used in appropriate ways. When utilized in an authorized manner, the items are categorized as controlled property

Long Range Acoustic Devices (LRAD)

LRADs may only be utilized as a public address system for commercial purposes. Any other use is not authorized.

Armored Vehicles

Armored vehicles may only be used for disaster-related emergencies; active shooter scenarios; hostage or other search and rescue operations; or anti-terrorism preparedness, protection, prevention, response, recovery or relief.

LEA's that do not have a current SPO Addendum on file by January 1, 2023 or who fail to annually certify that the vehicle(s) use is exclusively for the limited purposes, must return vehicle(s) to DLA Disposition Services.


Provide written or electronic notification of the local community of your intent to request controlled property

• If the notice of intent does not include a specific controlled property item, the item cannot be requested in the LESO program until 30 days after an updated notice is published

Civilian Governing Body Notification



Provide written or electronic notification

Include a comprehensive list of any controlled property that may be requested throughout the year

Give reasonable opportunity to review. Normally 30-days

Campus LEA's

- Obtain Board of Governors (or equivalent) explicit approval for the acquisition of controlled property
- Certify policies and training to include specific provisions on using controlled property in a way that does not chill speech, is not disruptive to the educational environment, and does not foster a hostile climate among students
- Campus LEAs who receive controlled vehicles are required to remove the militaristic appearance (i.e painting the vehicle a different color)

Regional Sharing Agreements

Contact Your LESO State Coordinator's Office

If you are part of a regional sharing agreement, you must adhere to requirements. Contact your SPOC to notify them of the agreement and receive instructions

Follow The Rules

The LEA conditionally loaning the controlled property will remain accountable to the LESO program to ensure all requirements are met

Policies and Procedures

LEA's must adopt and comply with general policing standards, controlled property standards, and record keeiping requirements, and training for controlled property



Significant Incident Report

- Violent encounter between civilians and police
- Use-of-force that causes death or serious bodily injury
- A demonstration or other public exercise of First Amendment rights
- An event that draws or could draw a large crowd, such as when advanced planning is needed



Tip: You must collect and retain significant incident information that involves the use of controlled LESO property

How: Examples include a police report, incident report or use-of-force report that includes that controlled property was used

Include name, quantity, make, model, serial #, etc. of controlled property used

Description of the action/operation

IWho used and directed the use of the controlled property

Civilians involved in the action/operation

Result of the action/operation

Make documentation available to the community (sensitive information exemptions)

Annual Certification

These requirements have resulted in additional certification statements.

- By signing the SPO Addendum you agree to the statements
- You will annually certify the statements during inventory certification. There will be additional boxes to check off on during inventory certification to certify compliance with the requirements
