VI. Update on Asian American Workforce

As of end of May the total number of Asian American Employees in coded positions was 1,166 which is 2.57% of the 45,290 code employees. That is an increase from quarter ending December 2014 in which the state employed 1,098 Asians out of the 44,279 (2.50%). State Troopers and Transportation employees under technical managers are not included.

As of the end of March the total number of Asians in middle management code positions (Public Service Administrators) was 99 out of 2,981 (3.32%). The number of Asians in PSA positions at the end of December was 93 out of the 3,018. There were no gains in this area.

For the upper management (Senior Public Service Administrators) there were 33 Asians at the end of March out of 1,211 (2.72%). Although the number of SPSA went down from 1,331 to 1,211 the number of Asians in SPSA code positions remained the same.

As of the end of fiscal 3rd quarter the total number Asian American underutilized was 413, half in Chicago Metro Area. Many under the professional titles.

Human Services, State Police, Veterans Affairs placed on notice by Human Rights for not meeting Affirmative Action goals. Human Services not meeting Asian American affirmative action.

Human Services, Dept. of Corrections, Transportation still hiring. This summer the hiring maybe slower for many state agencies.
