- iii. Small Group/Agency Targeted Discussions Committee—similarly, group memberships were confirmed and potential dates for upcoming meeting discussed. Meeting goals will be to discuss best practices and work with selected agencies to develop proactive responses to Plan goals. DCFS, DHS, and DOT offered to be among first agencies to meet with subcommittee. Choua Vue offered to join Agency Small Group Discussion subcommittee
- c. Review of plan and objectives: This topic was tabled for discussion at the next meeting. Similarly, the Small group subcommittee would determine which agencies it will meet with rather than have them in front of the entire council. It was also decided that no new subcommittee was needed to work on plan objectives for next year; this will be accomplished through current subcommittee structure.
