I. Discussion Items- Roberto Sanabria, Council Chair

Approval of Meeting Minutes.

Quorum was not achieved. Minutes will be tablet and voted on at the October Quarter 4 meeting provided there is a quorum. Chair Sanabria requested to receive the email addresses of all Council Member so he can attempt to contact and confirm attendance for the meetings.

Subcommittee Update on Agency Recognitions Awards

Vice Chair Preston was able to get awards, Company was not able to give the awards for free after all due to financial hardship related to COVID impact. Vice Chair Preston and Chair Sanabria will cover cost this time around but for future will need to figure out how to present awards if Council has no Budget. Roberto would like if Patricia can possibly look into whether the council has a budget.

Meeting and Job Fair in the Community – Patricia Santoyo-Marin – CMS Meeting in the Community are on pause for cautionary reasons. Once safety concerns are more conducive, the council will revisit scheduling for the meeting to take place in Hispanic/Latinx communities. Patricia updated that a location in Little Village has been secured a for a future meeting and next would be to secure a location in

Humbolt Park and then in other locations like Aurora, Quad Cities etc.. Per recommendations from the council, the idea would be to revamp and expand where the meeting would be followed by a job fair and include invitations to elected official to engage the community as a whole. Chair Sanabria Recommended that Local legislators be invited and that legislation calendars should be consulted so they are available to attend.

Online Application - council members' experience of completing new the online application

Chair Sanabria attempted to apply for a position to experience the online application process. The position however was a bargaining unit title which requires a CMS100 application, so he was not able to experience the full online process. Sarah explained that the one he attempted to a apply for was still transitioning into the electronic process. Sarah will provide the council some Merit Comp vacancies that go through the online process vacancies so they can go through the online application process to experience the new process.

Chair Sanabria asked if other State websites were reviewed in designing the website. Sarah confirmed that other state websites had been reviewed and compared in designing the Illinois website.

Data

Chair Sanabria asked when the council will start receiving workforce demographic data. Sarah explained that full picture data will be provided going forward once HCM is in full effect. The data currently available through HCM doesn't give full picture and are still working with the developers to make adjustments for accuracy. The council will get data from old system until new system is updated and can provide the data. The new system will document through that application process. Sarah shared visual samples to and noted that there are some individuals that do not respond. Chair Sanabria asked if have looked backwards to identify those who previously did not identify at application stage? It would be interesting to see what demographic is refraining to self-identify the most or percentage. Sarah was not able to confirm that there is something that ties the two. Can directly connect the proportions of applicants to those hired for those that did identify. Chair Sanabria provided the Federal definition of an "Applicant" indicating that in order to be considered an applicant for a position they must meet the minimum requirement so this should be reviewed in the data. This also alludes to the potential need to review the minimum requirements to see if they are a barrier.

Expanding the Council

Chair Sanabria asked what it would take to expand the council. Patricia is in the process of gathering information from Gov's office point person and will be providing information on the process to the council prior to next meeting. Chair Sanabria asked the Council members and Ex Officios to look for people to recommend for the council so they can apply be a part of the council and increase membership.

Partnership updates

Patricia shared that CMS has established a partnership with HACE and will be participating in their upcoming event. In addition to that they are building an infrastructure to reach out to colleges and universities, in particular Hispanic serving institutions. There is also an aim to partner with the Illinois Latino Council on Higher Education and establish authentic relationships that would yield a conversation around recruitment. The intent will also be to participate in more cultural celebrations and events and establish ourselves as partners in the community.

CMS hosts a monthly a statewide call and has revamped its structure to make the discussions more focused hosting a moderated panel discussion answering agency specific questions focused on finding solutions to challenges they face. The September meeting will be focused on Effectively Engaging the Hispanic Latinx Community. Council member wo will participate on the panel will get an email invitation with all the information necessary to access the meeting and participate.

Update On Meeting with DCFS Director

Survey Question

Jose Lopez noted that the survey questions were not on the agenda inquired as to the survey questions and whether there was a subcommittee working on them. Carlos Charneco asked the Council for their opinion on the progress of the State's new website and hiring Process. Chair Sanabria stated that the directors need to make more of an effort to hire Latinos in the positions where they have the ability to select the person who fills the role. They should be reaching out to more organizations and look outside their circles to find the candidates. Council Member Suleiman Gonzalez indicated that she has not had the opportunity to review the website but will do so prior to the next meeting in order to provide feedback.
